A. North – HOLLYWOOD BOULEVARD (south side, between La Brea Ave. and El Centro Ave)

B. East – EL CENTRO AVENUE (west side) between Hollywood Boulevard and Melrose Avenue;

C. South – MELROSE AVENUE (north side) between El Centro Avenue and Wilcox Avenue (east side) north to Willoughby Avenue (north side) between Wilcox Avenue and La Brea Avenue; and

D. West – LA BREA AVENUE (east side) between Willoughby Avenue and Hollywood Boulevard. Excludes any portion of La Brea Avenue within the boundaries of the City of West Hollywood
